Reimbursement will be based on the medical APG appropriate to the diagnosis. Use of procedure code M0064 (APG 426) to bill brief visits (i.e., up to 10 min) for clinically stable patients ended 12/31/2014. As of 1/1/2015, all psychiatric medical services delivered by Art 16 clinics --typically psychiatric medication management services-- should be billed using E&M CPT codes.
